RE: Request for FY18/19 special appropriations

Dear Governor Sandoval:

The Nevada Commission for Women, created by NRS Chapter 233I, was under review for possible termination by the 20132014 Sunset Subcommittee of the Legislative Commission due to its inactive status since the 1990's. However, you supported the notion that the Commission for Women played a vital role in championing women's issues in Nevada and decided that it should be reactivated. All of the women you appointed to serve on the Commission are very appreciative of the opportunity and are eager to make a difference for the betterment of women in our state.

The Commission for Women is comprised of 10 members with equal representation from the north and south, as well as balanced political party representation. The Commission has the duty to study the changing and developing roles of women in society, including the recognition of socioeconomic factors that influence the status of women, and recommend proposed legislation.

In order to diligently fulfill our duty, the Commission needs current research data and analysis. I am writing to request special appropriations from the fiscal year 2018/2019 budget to pay for a research report on the status of Nevada women which was approved unanimously at the Commission's June 17, 2016 meeting. The report (option #4 of the enclosed proposal) will be produced by the Kenny Guinn Center for Policy Priorities and is a much needed document to study trends, identify pertinent issues, and provide data-driven proposed legislation.

When the newly appointed Commission for Women members held its first meeting February 25, 2016, we had a carryover budget from the mid-'90's of \$1,500. This fund will be depleted in less than 22 months after paying the required worker's comp quarterly fee of \$177.90.

In addition to the request for special appropriations, the Commission is committed to seeking funding from multiple sources in order to sustain and grow its efforts. We have selected

Commissioner Brenda Hughes as a point-person to research and identify funding resources from the federal government, public foundations, and private donors. She will enlist the assistance of fellow members to write grants, solicit potential donors, vet funding opportunities, and conduct other fundraising work as needed. Conversations with grant-making foundations and other funding organizations are already underway.

Please find below a breakout of the Commission's funding request for special appropriations. We are primarily requesting funds to cover the cost of the Status of Women research report, but also need funding for travel, worker's comp, and office supply expenses. Worker's Comp is a required expense; the office supplies are needed for correspondence and meeting materials; and travel is needed for members to meet once a year in-person.

Background

Thank you for the opportunity to provide you with a formal proposal from the Kenny Guinn Center for Policy Priorities to support the work of the Nevada Commission for Women whose duties are as follows (per Nevada Revised Statute 233I.060):

- 1. The Commission shall study the changing and developing roles of women in society, including the recognition of socioeconomic factors that influence the status of women, and recommend proposed legislation.
- 2. The Commission may collect and disseminate information on activities, programs and essential services available to women in Nevada.

We believe that the Guinn Center, a state-wide bipartisan research center, is important to Nevada individuals and decision makers given its commitment to provide independent, data-driven analysis and solutions to decision makers in the public and private sector about the complex policy challenges facing our state, including the well-being of women (and their families).

We are pleased to provide the following options for your consideration.

A. Option #1: Full Report on The Status of Women in Nevada

This report would replicate the content and scope of the Institute for Women's Policy Research's (IWPR) 2004 *Status of Women in Nevada* report. Using publicly available data, this report would compare the status of women over the period 2000 and 2010.¹ The report would also compare Nevada to its Intermountain West neighbors.

¹ The Guinn Center is unable to replicate any IWPR proprietary calculations contained in the Status of Women Report. That said, we will include the raw data and calculate our own measures, as deemed appropriate and relevant.

This full report would include information on the following seven categories: Work and Family, Employment and Earnings, Poverty and Opportunity, Health and Well-Being, Violence and Safety, Reproductive Rights, and Women's Political Participation.²

Under this option, the Guinn Center would assume the role of project coordinator and work closely with Dr. Joanne Goodwin of the University of Nevada, Las Vegas (UNLV) to coordinate the work of the UNLV faculty team who have expressed an interest to collaborate on this project. The Guinn Center would oversee the scope of all faculty-authored papers and their alignment to the Status of the Women report.

Cost of the report \$40,000. Time of completion: 6 months

B. Option #2: Policy Briefs on Selected Topics

The Guinn Center could narrow the scope of its research and analysis to a select number of topics among the complete list of seven categories outlined above (e.g., Work and Family, Employment and Earnings, Poverty and Opportunity, Health and Well-Being, Violence and Safety, Reproductive Rights, and Women's Political Participation.)

Cost of each policy brief: \$5,000. Time of completion: 2 months

C. Option #3: Fact Sheets on Selected Topics

The Guinn Center could compile a Fact Sheet on a select number of topics among the complete list of seven categories outlined above (e.g., Work and Family, Employment and Earnings, Poverty and Opportunity, Health and Well-Being, Violence and Safety, Reproductive Rights, and Women's Political Participation.) The Fact Sheets contain information on the raw data. The Fact Sheets do not include any analysis or recommendations.

Cost of each Fact Sheet: \$2,000. Time of completion: One month

D. Option #4: Report on the Status of Women and Policy Outreach

This report would replicate the content and scope of the Institute for Women's Policy Research's (IWPR) 2004 *Status of Women in Nevada* report. Using publicly available data, this report would compare the status of women over the period 2000 and 2010.³ The report would also compare Nevada to its Intermountain West neighbors and its other relevant peers.

² Here we list a selection of some of the indicators that will be used: Work and Family, Employment and Earnings (e.g. ratio of men's earnings to women's earnings, women's labor force participation), Poverty and Opportunity (e.g., percent of women above poverty, women's business ownership), Health and Well-Being (e.g., mortality from cancer), Violence and Safety (e.g., int mate partner violence and statistics), Reproductive Rights (e.g., mandatory consent, restrictions on public funding), and Women's Political Participation (e.g., voter registration, voter turnout).

This full report would include information on the following seven categories: Work and Family, Employment and Earnings, Poverty and Opportunity, Health and Well-Being, Violence and Safety, Reproductive Rights, and Women's Political Participation.

Under this option, the Guinn Center would assume the role of project coordinator and work closely with Dr. Joanne Goodwin of the University of Nevada, Las Vegas (UNLV) to coordinate the work of the UNLV faculty team who have expressed an interest to collaborate on this project. The Guinn Center would oversee the scope of all faculty-authored papers and their alignment to the Status of the Women report. This report would include detailed, specific recommendations and draw on best practices from other states.

Under this option, the Guinn Center would produce 1-2 (additional) policy briefs that would use the data and the analysis contained in the full Status of Women report and refer to upcoming legislative priorities, as identified by the Commission for Women. As an example, if the Legislature were to consider pay equity legislation, the Guinn Center could write a policy brief that includes some of the information in the Employment and Earnings section while analyzing the specific legislation.

In addition, following the final release of the report, the Guinn Center would be available to prepare standard presentations that the members of the Commission for Women could use to share the information contained in the report.

Cost of the report \$50,000. Time of completion: 7 ~ 9 months

Recently aff liated with The Lincy Institute in Nevada, Dr. Turner's efforts have chiefly focused on designing and implementing a pay-for-performance program for a large urban district and on developing value-to-cost ratios to gauge the effectiveness and efficiency of schools, programs, and departments. From 2011-2014, Dr. Turner led efforts to apply performance management tools in a district of 316,000 students; this included guiding the launch of a growth model and School Performance Framework. A year and a half after joining Clark County School District, the graduation rate increased and scores rose in 11 of 14 areas of state assessment. This occurred despite a \$550M reduction over a three-year period in an annual operating budget of \$2.1B. In that time, the graduation rate improved from 59 to 71.5 percent. Dr. Turner also led and supported district efforts to: (a) reduce disproportionality by race/ethnicity with respect to expulsion; (b) develop models to anticipate facility failures that can halt teaching and learning or impact fund balance; (c) institute a process so schools gain flexibility in budget, staffing, and programming in return for greater accountability for improved student performance.

From 2007-2010, Dr. Turner was Deputy Commissioner of Education in Colorado. There he directed the revision of state standards for 13 subjects, guided reorganization of accreditation, and launched an academic growth model, which has informed similar models in 20 states. Dr. Turner has played an important role in other efforts. In 2009, he served on a 12-member team that advised the National Governors' Association on a national assessment system. In 2006, he was a founding trustee of AdvancED, an agency that accredits 30,000 schools in 70 nations. From 2008-2011, he served on the Education Committee of International Baccalaureate Board of Governors and helped shape IB programs in 3,600 schools in 146 countries.

Dr. Turner earned his doctorate at Harvard in 1991. A year later, Harvard, Columbia, and the University of Pennsylvania named him recipient of the Goldie-Anna Trust Award for dissertation of the year in the field of education.

Senior Fellow Dr. Leslie Strasser Murdock is the owner of the ELM Educational Consulting Firm, a firm dedicated to ensuring that children receive the best possible education for their unique learning styles and needs. Under ELM, Dr. Murdock represents children and families looking to obtain necessary school services and also represents the Clark County Department of Family Services (DFS) where she acts as the Educational Liaison between DFS and the Clark County School District.
