Ms. Barber stated that the goal is to have everything done and fabricated by the end of August or first of September. Ms. Barber will be working with the Nevada State Library and Archives on information for the final panel which the Commission decided would be on the History of the Commission for Women. Commissioner Bender informed the Commission that before moving forward with the parade, she will find out and present to the Commission the financial obligation of the Commission; she hopes to have this information by the Strategic Planning Session.

- 1. Publicize results, share reports, social media, Sierra Forums in Carson City (and other speaking), tell our story.
 - a. Commissioner business cards have been completed and are in the mail.

Chair Diane Fearon updated the Commission on Goal Number 5:

- 1. Create a voluntary Gender Equality Survey with the Secretary of State's office to recognize businesses working to achieve gender equality.
 - a. 504 business, government entities, and/or nonprofit organizations have completed the survey.
