1. Fundraising

Commissioner Diane Fearon reported that Bank of America is eager to get a report of the 2019 grant given to the Commission for Women, as they are willing to grant the Commission funds in 2020 for capacity building. Ms. Walt informed the Commission for Women that the 2019 granted funds are still in the Community Foundation of Western Nevada account. Ms. Walt asked Commissioners if they are interested in starting to plan the Commission Strategic Planning Session in the upcoming months, she would help facilitate the planning. Commission Fearon voiced her reservation with planning the Strategic Planning Session without a Chair to the Commission being appointed. Commissioner Bender suggested moving forward with the planning of a Strategic Planning Session, so the Commission can hear from the newly appointed Commissioners and what they are interested in the Commission working on. Ms. Walt informed the Commission that an email providing possible dates in March would be sent out for Commissioners to inform Ms. Walt of their availability. If a Chair is not appointed by the time travel plans need to be made, then the session could be postponed if that is the direction of the Commission for Women.

- Goal: Gender Disparity/Equality Issues in Nevada Ms. Walt reported on the roundtable discussion held on November 8, 2019. The discussion was video conferenced to/from Las Vegas and Carson City. Group is looking forward to the 81st Legislative Session.
- Increase the Number of Women in Leadership Ms. Walt reported that she is communicating all the state board and commission opening to the Commission's ListServ subscribers monthly.
- Participate in Women's Suffrage Ms. Walt informed the Commission on the Nevada Women's Suffrage Celebration Committee that was formed in September. Ms. Walt is Chair of the committee. Events, projects, and programs are listed on the committee website www.nv19thamendmentcentennial.com.
- Budget Ms. Walt reported to the Commission the account balance for the Commission's state account to be \$6,426.00 and the Community Foundation of Western Nevada has balance of \$8,794.00. Ms. Walt noted that \$5,000 of the balance from the Community Foundation is earmarked for the Commission's Capacity (Strategic Planning) Building Workshop and \$878.00 for the Elevate HER NV campaign.
