In 1963, the National Federation of Business and Professional Women's Clubs proposed that state governors create commissions patterned after the Presidential Commission. According to files in the Research Library, in 1964 Governor Grant Sawyer created Nevada's first Commission on the Status of Women by executive order. The second commission was created in 1967 by Governor Paul Laxalt. The structure for both of these commissions included a chair, two vice chairs, and seven committees-citizenship, community service, education, employment, legislation, public information, and social insurance and taxes.

٠

In 1969 and 1971, legislation was introduced in the Nevada Legislature to create in statute a commission on the status of women. Both bills failed. In 1975, Governor Mike O'Callaghan changed the Commission on the Status of Women to a focus on the status of people. The Governor authorized the new commission to investigate state laws that discriminate against all Nevadans. It would appear that this commission was discontinued sometime after 1975.

Nevada Commission for Women

In 1991, Senate Bill 574 was enacted to create the Nevada Commission for Women. According to minutes of the hearings, supporters argued that a commission would act as a clearinghouse for information. Opponents argued that such a commission would promote a feminist political agenda. This bill contained an expiration date of July 1, 1995.

The expiration date was repealed by Assembly Bill 116 in 1995. In addition, A.B. 116 included an appropriation of \$10,000.

The Research Library has among its holdings the *Report to the Governor and the Legislative Commission*, Nevada Commission for Women (1992, 1993), which was required by NRS 2331.050, until that report was deleted in 2013 with the passage of S.B. 405.

In addition, the Research Library has the following publications produced by the Commission:

- Nevada Women's Legal Guide, Nevada Commission for Women (1995); and
- Domestic Violence: A Handbook for Victims and Professionals, Nevada Commission for Women (1998).

In the Directory of State and Local Government, the last listing of members was in 1999.

Conclusion

You might be interested in the National Association of Commissions for Women (<u>http://www.nacw.org/</u>), which has divided the nation into 10 regions; Nevada is in Region 9. You can find information on its website about the active commissions in other states as well as some local level commissions. It also appears that the National Association has held national conferences, although information about a 2016 conference is not available on the website.

You might also make contact with the Nevada Women's Lobby (<u>http://nevadawomenslobby.org/</u>). Marlene Lockard is the lobbyist for the organization. She testified in support of reactivating the Commission for Women, as proposed in A.B. 134 in the 2015 Session. Nevada Commission for Women By-Laws 2021

I. Purpose

The Nevada Legislature approved the reactivation of the Commission for Women with passage of NRS 233I. The Commission for Women is comprised of 10 members who reflect the diversity of Nevada and balanced political party representation. These By-Laws govern the Commissioners as they dedicate their service to the State of Nevada.

The Commission is charged with the responsibility to study the changing and developing roles of women in society, including the recognition of socioeconomic factors that influence the status and equality of women, and recommend proposed legislation for consideration. Staff support is provided to the Commission by the Department of Administration.

II. Membership

A. Chair

The Governor designates one (1) member of the Commission to serve as Chair for a term of one (1) year who may be reappointed by the Governor for one (1) additional term. The Chair may schedule additional meetings or special meetings but must ensure meetings are held no less than once per quarter. Meetings are to be held in locations in both Carson City and Las Vegas and ZOOM may be utilized at the direction of the Chair to facilitate attendance and participation by all members.

With approval of the Commission, the Chair may appoint committees from its members to assist with any functions or duties of the Commission. The Chair will remain knowledgeable of all Commission policies and Department of Administration policies. The Chair will maintain communication with the Department's assigned staff and will consult its assigned Deputy Attorney General on any legal matters. The Chair will also keep the Vice Chair current on any items involving the Commission.

B. Vice Chair

The Governor designates one (1) member of the Commission to serve as Vice Chair for a term of one (1) year. The position may be reappointed by the Governor for one (1) additional term. The Vice Chair will lead the meeting in the absence of the Chair and shall have all the powers and duties of the Chair during the absence. The Vice Chair will remain knowledgeable of all Commission policies and Department of Administration policies. The Vice Chair will maintain communication with the Chair, the Department of Administration's designated staff person and will consult its assigned Deputy Attorney General for all legal matters regarding the Commission.

C. Commissioners

The Governor is responsible for appointing ten (10) Commissioners for the Commission. Each appointee's term of office is three (3) years but will continue until such time a successor is officially appointed. A Commissioner may be reappointed but may only serve two (2) consecutive terms. If a Commissioner chooses to resign from her position before the end of her term or before a successor is officially appointed, the individual may submit a written request to the Governor's office and inform the Chair and Vice Chair of the request. Each Commissioner will remain knowledgeable of all Commission policies and Department of Administration policies and maintain any and all commission communication through the Chair, or in her absence, the Vice Chair.

If any Commissioner has two (2) consecutive unexcused absences from the regularly scheduled meetings during the fiscal year (July through June), the Commissioner will automatically be placed on an inactive status and the Chair will send a recommendation to the Department of Administration Director stating that the individual's membership should be terminated. The Director of the Department of Administration will review the recommendation and if in agreement, the Director will forward a response to the Governor's office who has the authority to remove any member of the Commission. If the Governor's office is in agreement, the Governor shall provide the member in writing of a forty-five (45) days' notice of removal unless the Governor determines circumstances warrant an immediate removal.

III. Meetings

The Commission will adhere to the State of Nevada Open Meeting Law when planning and or conducting meetings. The Commission shall meet at the call of the Chair as frequently as required to perform their duties but no less than quarterly. There must be a minimum of six (6) Commissioners in attendance to achieve a quorum. Only a quorum will allow for any official action to be taken by the Commission. The Chair is responsible for preparing the agenda for the Commission. Items to be placed on the agenda for regular meetings must be on file with the Chair a minimum of fifteen (15) days before the scheduled meeting. Any Commissioner may request that an item be placed on the agenda after consultation with the Chair. The Chair must send the agenda to the Department of Administration's designated staff person for final approval of all agenda items. The Department's designated staff person will send the agenda to the Deputy Attorney General to receive legal approval. Once approved, the individual will prepare the agenda for ADA compliance and will be in charge of posting the agenda.

IV. Funding

The Commission may apply and receive gifts, grants, contributions, or other money for carrying out the duties outlined in NRS 233I. The Commission will designate one (1) fundraising lead. This person will coordinate fundraising strategies, activities and will facilitate fundraising efforts of the Commission. This person will provide regular updates to the Chair, Vice Chair, Commissioners, and the Department of Administration's designated staff member. All fundraising events and items may include but are not limited to: flyers, letters, and other public material that require approval the Department of Administration Director prior to release or distribution.

All donations will be deposited to either the Commission's State Budget account or to the Community Foundation of Western Nevada account. Donations deposited to the Community Foundation of Western Nevada account may be transferred to the State budget account when approved by a majority vote of Commissioners.

Any purchase approved by a majority vote of Commissioners approval of the Director of the Department of Administration before any withdrawal of available funding may be used. The appropriate state protocols must be used and any supplier, contractor, and/or vendor must be registered with the State's Controller's office prior to any contract award.

Commissioners receive no compensation for their services but are entitled to be reimbursed for all travel and other expenses that are necessary for them to perform their duties, within the limits of money available from gifts, grants, contributions, and other money received pursuant to NRS. Expenditures of money including in-kind donations must be approved by the Commission. Commissioners will read and follow the State Administrative Manual (SAM) before planning any travel.

The Chair must receive permission from the Department of Administration's Director before the expenditure of funds or to provide reimbursement to a Commissioner. The Commission nor its members may not be reimbursed for food or refreshments, pursuant to the State Administrative Manual (S.A.M.).

V. Department of Administration

The Department of Administration's Director will provide staff assistance to the Commission in carrying out the duties and responsibilities of the Commission, as the Governor deems appropriate. The Commission may solicit volunteers or pro bono consultants for specific projects pursuant to the NRS.

The Department of Administration's designated staff will update all Commissions websites and social media platforms. If the Commission wants to create a new online account or website, they must get prior approval from the Director's office. The designated staff member will maintain the confidential passwords for the Commission and will not provide such information to the public. Commissioners will review websites and social media platforms and contact the Chair regarding any updates that need to be made or with any social media content they would like the Commission to share. The designated staff member must receive approval from the Department's Public Information Officer and/or the Director's final approval regarding all new or revised or additional public content.

All media advisory, press releases, communication for public consumption and political inquires must go through the Department of Administration for approval. Commissioners cannot represent the Commission to any of the listed entities without the Director's prior approval. No Commissioner may use her seat on the Commission to endorse or raise campaign funds in the name of the Commission for any candidate for public office.

Commissioners are required to follow all policies and procedures listed in the State Administrative Manual (SAM) which can be accessed online at <u>budget.nv.gov</u>. It is the responsibility of each individual Commission member to be informed of all relevant laws, policies and procedures that pertain to the Commission. Any specific questions or inquiries are to be made through the Chair who may refer such to the Director of the Department of Administration.

On June 22, 2021, I spoke with Liz Mumford who is one of the owners of Mabble Media. We talked about the Commission taking over the Elevate Her website and how things were set up with the past contract that we had through Fior Partners. Initially Mabble Media set up the website as a pro bono project and handed it off to Molly. Molly was supposed to let Mabble Media know if any edits were needed but there was no maintenance plan or goals in place so the website was not being taken care of like it should have been and the domain went down.

Mrs. Mumford told me that her company can provide training sessions that would involve navigating and updating text on the website and the fee for each session would be \$150.00 per hour. If training sessions end up being less than an hour the price would range from \$75.00 to \$150.00. The Commission would also need to establish a state contract through Mabble Media to develop a maintenance plan. This would prevent the Commission from the problems they had in the past where the website went down without anyone's knowledge. The monthly maintenance plan is \$125.00 where Mabble Media conducts a sweep of the site once a month. If the Commission needs to call Mrs. Mumford for any problems that may occur before the monthly maintenance, then there would be an additional fee between \$150.00 to \$300.00 per hour. Mabble Media generally takes one to two hours for correcting problems depending on what changes were made.

It seems clear that the Commission would save its resources by using the existing Commission for Women website within the State's content management system instead of updating and maintaining a separate Elevate Her website. The State web services staff and I can work on keeping the Commission for Women website updated and there would already be a maintenance plan in place that the Commission would not have to pay any additional fees to maintain. We can transfer the content from the Elevate Her website to the Commission for Women website where we can place it below the Commissions Missions and Goals. The Commission would just need to develop a proactive plan on what information they want to include on our state website. We also have Facebook, Instagram, Twitter and YouTube for the public as well. With these media platforms and the main Commission for Women website, the Commission can help direct the focus of the public without causing any confusion by having to navigate multiple websites.

Please let me know if you wish to agendize this matter for discussion on a future meeting, and I would be happy to do so.


