#### SUBJECT: Statewide Grant Management System Needs Assessment

#### Your participation is requested

The Office of Grant Procurement, Coordination, and Management (Nevada Grant Office) is authorized by <u>Assembly Bill 445</u> of the 2021 legislative session to procure a statewide Grant Management System (GMS). To ensure the system purchased will best meet the needs of agencies, the Nevada Grant Office will hire a consultant to conduct a Needs Assessment in spring 2022.

In preparation for this Needs Assessment, the Nevada Grant Office is compiling a contact list of those wishing to provide input on what they need from the system. This list will be provided to the consultant. Input may be requested by the consultant via surveys, interviews, or other methods.

#### Goals of the GMS Needs Assessment

The GMS should increase accessibility and ease of identifying, applying for, and managing federal grants, and provide data that will allow the state to reduce duplicative efforts, increase intra-agency collaboration, and improve Nevada's ability to receive and manage federal grant dollars.

The goal of the Needs Assessment is to gather specific agency and user information to help identify what the state requires from a GMS. To achieve this, and to ensure all user perspectives are included, feedback from all impacted agencies is essential.

Through the Needs Assessment process, coupled with knowledge acquired from our past experiences in seeking a GMS, the Grant Office will be able to identify what GMS users need



from the system and incorporate this information into an RFP that we anticipate having prepared and ready by July 2022.

## Background & other upcoming changes

The Needs Assessment and development of the GMS RFP are an important part of the work of the Nevada Grant Office as we prepare for other big changes resulting from Assembly Bill 445. Beginning July 2022, the Grant Office will transition from the Department of Administration to the Governor's Office and be renamed the Governor's Office of Federal Assistance. Since its creation in 2011, the Nevada Grant Office has remained nimble and continued to evolve to address the dynamic challenges facing Nevada organizations seeking grant dollars. Assembly Bill 445 continues this momentum by establishing the next phase of the office's evolution in its mission to bring more federal grant dollars into the state, including authorizing the purchase of a statewide GMS.
