SUBJECT: **Wiring, Cabling, Fiber Communications Infrastructure**

The Purchasing Division is pleased to announce new statewide contracts with Comtech Communications (99SWC-NV22-12210), Conway Communications, Inc. (99SWC-NV22-12209), Diversified Communications Solutions Inc., Ltd. (99SWC-NV22-12212), and Eagle Communications LLC (99SWC-NV22-12211) for ongoing, as-needed repairs and installations of state communications infrastructure including wiring, cabling, and fiber (WCCI) and/or telephone equipment in multiple areas. These are mandatory contracts for all Nevada executive branch agencies of state government (including boards and commissions) and available on a voluntary basis to the Nevada System of Higher Education, the judicial and legislative branches of state government, local governments, and districts.
